BOUNTY LAND CLAIM.

STATE OF MAINE, } ss.

COUNTY OF *Kennebec*

On this *second* day of *May* A. D. one thousand eight hundred and fifty-*five* personally appeared before me, *Emory O. Beane* a Justice of the Peace, within and for the County and State aforesaid,

aged *Sixty two* years, a resident of *Fayette* in the State of Maine, who, being duly sworn according to law, declares that he is the identical *Bunker Kent*

who was a *private* in the Company commanded by Captain *John Smith* in the Regiment of *Massachusetts Militia* commanded by *Col. Ellis Sweet* in the war with Great Britain, declared

by the United States on the 18th day of June, 1812, *That the company of Capt. Smith was called into service on the 13th day of September A.D. 1814. That he served in said company until about the fifth day of October A.D. 1814. where he was formally discharged as he believes will appear by the Muster Rolls of said company. That he received pay for the sum of*

for the term of *fourteen days; or more* that he has heretofore made application for bounty land under the act of September 28, 1850, and received a land warrant, No. , for acres, which he has

since legally disposed of, and cannot now return. *That the company of Capt. Smith was called into service to defend the coast of Maine. That he never received any written certificate of discharge but was verbally discharged. He declares that the amount which was claimed on the application he furnished to Emory O. Beane, Recorder of the Maine.*

He makes this declaration for the purpose of obtaining the additional BOUNTY LAND to which he may be entitled under the "Act approved March 3, 1855." He also declares that he has never applied for nor received, under this or any other act of Congress, any bounty land warrant except the one above mentioned. *nor made any other application therefore*

That I, _____ of _____ in the _____ and State of Maine, have constituted and appointed _____ of _____ County of _____ in the State of Maine, my true and lawful Attorney, irrevocably, for me and in my name, to prosecute and receive from the United States the Bounty Land Certificate, or Warrant, due me under existing Laws granting Bounty Lands for services rendered in the United States in the different wars, and generally to do all lawful acts and things whatsoever touching the premises, and an attorney or attorneys under him, for the purpose aforesaid to make, and at his pleasure to revoke, hereby confirming all and whatsoever my said attorney shall in my name legally do, or cause to be done, in the premises.
