This indenture made and entered into this thirteenth day of August in the year of one thousand eight hundred and forty two by and between Emerillis Kent of the County of Union and State of Ohio of the one part and Daniel Kent of the County of and State of Ohio of the other part witnesseth that the said Emerillis Kent for and in consideration of the sum of One hundred eighty three dollars and seventy five cents to her in hand paid by Daniel Kent the receipt whereof is hereby acknowledged hath bargained and sold and do hereby grant bargain sell alien and confirm unto the said Daniel Kent his heirs and assigns forever all that tract or parcel of land situate in Union County and in the Town of ^{Ship} ~~Mill~~ Creek and also aforesaid which is described as follows to wit being part of Survey No 3006 in the Virginia Military district so called Beginning at a bush and non wood N & corner to lot No 12 by subdivision thence S 90 W 85 poles to a stake thence S 15 E Ninety one poles to a stake thence E 90 N 55 poles to a sugar tree and bush beginning corner of survey No 3006 thence N 18 W 91 poles to the Beginning containing forty eight acres and too and also this further lot of the same survey and adjacent to the aforesaid Beginning at the above corner of a bush and Ironwood thence S 18 E 1 1/2 poles to a stake in the middle of the State Road thence with said road N 64 E 8 poles to a stake in the aforesaid Road thence N 60 W 8 poles and 1/2 links to the Beginning One fourth of

 assigns the sum of One hundred and eight three dollars and seventy five cents
 together with the legal interest that may become thereon in manner particularly
 specified in a certain note or obligation bearing ever date hereunto executed
 by Emerille Kent to the said Daniel Kent said Note becomes due on the
 30th day of August A D 1848 and if said Note is punctually paid in
 manner aforesaid and from thenceforth these presents and every thing
 herein contained shall cease and become void any thing to the contrary
 notwithstanding
