This mortgage made and entered into this twenty ninth day of July in the year of our Lord one thousand eight hundred and forty by and between Emerillus Kent of the County of Union in the State of Ohio of the one part and Mylo Skinner of the County and State aforesaid of the other parts Witnesseth that the said Emerillus

Kent for and in consideration of the sum of fifty eight dollars and sixty six cents to her in hand paid by Mylo Skinner the receipt whereof is hereby acknowledged hath bargained and sold and do hereby grant bargain sell alien and confirm unto the said Mylo Skinner his heirs and assigns forever all that tract or parcel of land situate in the County of Union and in the Township of Millcreek and State aforesaid which is described as follows to wit being part of Survey No 3006 in the Virginia Military District so called beginning at a beech and Ironwood N E corner to lot 12 by subdivision thence S 80° W 85 poles to a stake thence S 18° E 91 poles to a stake thence S 80° W 85 poles to a sugar tree and beech Beginning corner of Survey No 3006 thence N 18° W 91 poles to the beginning containing forty eight acres and 1/20 and also this further lot part of the same Survey and adjacent to the aforesaid beginning at the above corner of a beech and Ironwood thence S 18° E 16 poles to a stake in the middle of the State Road thence with said road N 84° E 8 poles to a stake in the aforesaid road thence N 60° W 8 poles and 30 links to the beginning containing one fourth of an acre also one other piece of the same Survey beginning at the aforesaid beech and Ironwood and running N 80° W 1/2 poles and 15 links to a stake in the East line of Elijah Skinner lot thence S 41° E 17 poles to a stake being the N E corner of said E Skinner lot thence N 80° E 32 poles to the beginning 130 poles to have and to hold the premises aforesaid with all the privileges and appurtenances thereto belonging or in any wise appertaining unto him the said Mylo Skinner and his heirs and assigns forever these presents are upon this express condition that if the said Emerillus Kent and her heirs executors or administrators or assigns shall pay or cause to be paid to the said Mylo Skinner his certain attorney or attorneys his executors administrators or assigns the sum of fifty eight dollars and sixty six cents together with the interest that may accrue thereon in manner particularly specified in a certain note or obligation bearing even date hereunto executed by the said Emerillus Kent to the said Mylo Skinner said note or obligation becoming due on the first day of January 1841 And if the said payment is punctually paid in manner specified aforesaid and from thence forth these presents and every thing herein contained shall cease and become void and any thing herein contained to the contrary

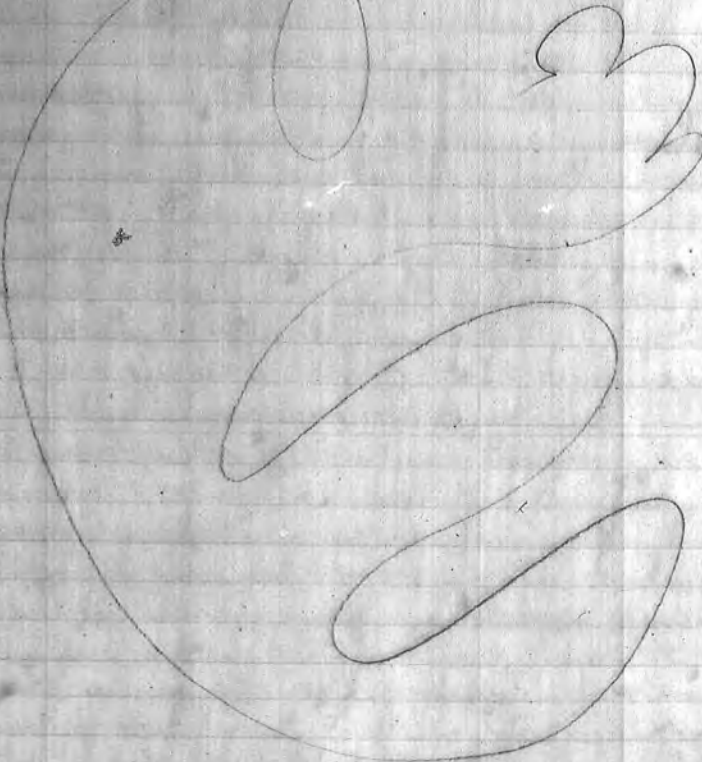
