 Clements & Orahood } Horatio T Kent of the county of Union & State of Ohio
 of the one part & Ransom Clements & Caleb Orahood of
 the county of Union and State of Ohio of the other
 part witnesseth that the said Horatio T Kent for and
 in consideration of the sum of forty one dollars and eight eight cents to
 him in hand paid his receipt whereof I do hereby acknowledge and for
 ever acquit and discharge the said Ransom Clements & Caleb Orahood
 their heirs executors & administrators have granted bargained sold and
 confirmed and by these presents do grant bargain sell & confirm to the
 said Ransom Clements & Caleb Orahood their heirs and assigns forever
 all that tract or parcel of land lying and being in the county of Union
 N^o Survey 6563 and State of Ohio aforesaid containing seven acres and
 one hundred and twenty six poles more or less and bounded as follows
 to wit Beginning at a Stone in the Centre of Mill Creek marked
 S & thence west thirty poles to two Symms thence south 60 west
 14 poles passing an Elm Stump to a Stake in Levi Coartens line
 thence with his line north & east 52 poles to a Stake in the
 Centre of the Creek in Ransom Clements South west corner
 thence down the Creek with his line south 60 east 96 poles thence
 South 14 west 18 poles thence south 50 west 13 poles to the Beginning
 together with all improvements & appurtenances whatsoever to the
 said premises belonging or in any wise appertaining and all the estate right
 title interest claim and demand of him the said Horatio T Kent of in
 and to the same To Have and to hold the Land here conveyed with
 all the premises and every part and parcel thereof with every of the
 appurtenances unto the said Ransom Clements & Caleb Orahood their heirs

and assigns forever and the said Horatio T Kent and his heirs all and the premises hereby bargained and sold with the appurtenances unto the said Hanson Clements & Coles Orakood and their heirs and assigns against the said Horatio T Kent and his heirs and all and every other person or persons whomsoever do and will warrant and forever defend by these presents in Testimony whereof I the said Horatio T Kent have hereunto set my hand and seal the day and year first in this indenture written
