Samuel Griffin This Indenture made this 4th day of July in the
year of our Lord one thousand eight hundred and
thirty seven between Samuel Griffin and Mary
Griffin his wife of the County of Union and
Horatio T Kent State of Ohio of the one part and Horatio T Kent
of the County of Union and State of Ohio of the
other part witnesseth that the said Samuel Griffin and wife Mary
for and in consideration of the sum of forty one dollars and eighty eight
cents to them in hand paid the receipt whereof they do hereby ack
nowledge and forever acquit and discharge the said Horatio T Kent his heirs
executors & administrators have granted bargained sold & confirmed and by these
presents do grant bargain sell and confirm to the said Horatio T Kent his
heirs and assigns forever all that tract or parcel of land lying and being
in the County of Union & Survey 6563 and State of Ohio aforesaid
containing Seven acres and one hundred and twenty six poles more or less and bounded
as follows to wit Beginning at a stone in the center of Miller creek Main branch
thence west thirty two poles to two lynes thence south 160 west 14 poles
passing an elm stump to a Stake in Levi Carters line thence with his
line North & east 52 poles to a stake in the centre of the creek in
Ransom Clements South west corner thence down the creek with his line
South 60 East 86 poles thence South 14 west 18 poles thence South 50
east 13 poles to the Beginning Together with all improvements and app
urtenances whatsoever to the said premises belonging or in any wise
appertaining and all the estate right title interest claim and demand
of them the said Samuel Griffin and his wife of in and to the
same to have and to hold the land hereby conveyed with all the
premises and every part and parcel thereof with every of the appurten
ances unto the said Horatio T Kent his heirs and assigns forever
And the said Samuel Griffin and his wife and their heirs all
the premises hereby bargained and sold with the appurtenances unto the
said Horatio T Kent and his heirs and assigns against the said
Samuel Griffin and Mary his wife and their heirs and all and
every other person or persons whomsoever do and will warrant and
forever defend by these presents In testimony whereof they the
said Samuel Griffin and his wife have hereunto set their hands
and seals the day and year first in this indenture written

Amos Beach assigns forever the following premises in Union
County Ohio to wit lot No 7 in Survey No 2911
in the Virginia Military district beginning at 2 beeches and sugar
tree thence N 80 875 poles to 2 beeches & sugar in the east line
of the survey thence N 10 W 82 poles to two beeches thence S 90 W
175 poles to 3 beeches thence S 10 8 82 poles to the Beginning
Containing Ninety acres more or less To Have and to hold
said premises with their appurtenances unto said Amos Beach
his heirs and assigns forever And said Syme Starting for himself
his heirs to both hereby Covenant with said Amos Beach his heirs
and assigns that he will forever warrant and defend said
premises with the appurtenances against the claims of all persons
