A search was made but the Seven States index to land entries in the public domain in \_\_\_\_\_ prior to 1908 did not show the requested entry.

A search was made but the index to post-1908 land entries in the public domain did not show the requested entry.

A search was made but the Records of the Bureau of Land Management (Record Group 49), including those of the former General land Office, document only the original transfer of tland from the United States to another party. Later land transactions are not recorded by the U.S. government, but by the county or state in which the land is located.

A search was made but the requested Land Entry record was not found. There is a gap between file # \_\_\_\_\_ and file # \_\_\_\_\_. These files could have been missing or lost before they were accessioned by the National Archives.
