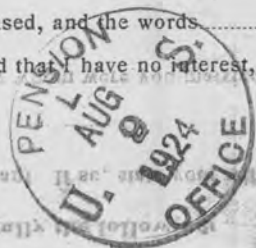

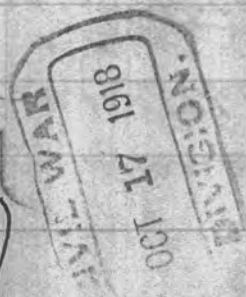

The leaf from which the above record is made is detached from any book but has at the top of the leaf the word in large letters "Family Record". but there is nothing to tell the nature of the Book from which it is taken or its date of publication. The appearance of the writing indicates that the entries in the Name and Date of Birth Columns were all made a good many years ago but the dates of Death in some instances show that it was made later. The only date appearing to have been changed was the date of Birth of Isabell Kent^{which} was changed from 1886 to 1804. showing this entry must have been made in 1886 or later.

The writing generally appears to be in one hand writing & to have been done at one time

On this 26th day of October 1909. personally appeared before me a Notary Public in and for said county and states, Levi Kent aged 62 years, a resident of Albion, Marshall County Iowa. who being duly sworn according to law declares as follows,

that the names of his father was Absalom P Kent, and that his mothers name was Isabel. Worth, Kent, and that he lived with his parents from the time that he was born until they died, his father Absalom P. Kent died here in Albion Iowa the 29. day of August 1882. and his mother, Isabel, Worth Kent lived with him until after his father died, and then went from here back to Saint Joseph County Indiana and died there on the 10th day of January 1885. while living at her daughters, Mrs Sallie Claybaugh. his parents lived with him for a long time prior to his fathers death, and prior to the time your affiant was married he lived with them both in Indiana and Iowa, he lived with them in Owen county Indiana up to September 1865 when they come to Iowa, and lived here all the time since then,

When they lived in Indiana they lived in Jefferson township, and their post office was Arney, and while they lived in Iowa they lived for a part of the time in Marietta, Marietta township, and the balance of the time in Albion, Iowa township Marshall county,

He claims that he made an application for pension under acts of February 6. 1907 about the 18. day of March 1907. and in said Application he stated that he was born on the 22, day of February 1845. this was a grand mistake as he was born on the 22nd day of February 1847 in Coshockton County Ohio, the reasons that he done this was on account of his forgetting his true age, when he enlisted his age was given as 18 years, and this was the cause of him giving the age that he did give, but when he come to consult those of his family who knew something about his true age he found out different, so he makes this affidavit to correct this error, that his post office address is Albion, Marshall County Iowa,
